**EXPLANATORY NOTE**

Section 76 of Republic Act 7160, otherwise known as the Local Government Code of 1991, mandates that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission.

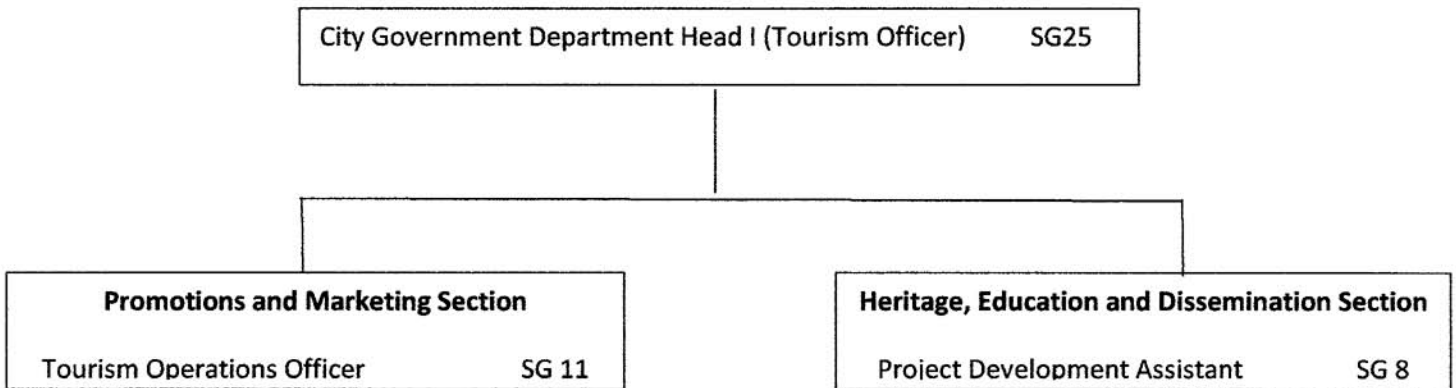
Realizing the necessity and relevance of creating an office that will focus on the development of tourism services and potentials of the city as well as manage its culture and arts programs and projects, the Sangguniang Panlungsod created the City Tourism and Cultural Affairs Office (CTCAO) in the City of Koronadal and the position of City Government Department Head I (Tourism Officer) through Ordinance No. 23, Series of 2020. In support to such creation, an organizational structure must be established, hence, this Ordinance:

**AN ORDINANCE APPROVING THE ORGANIZATIONAL STRUCTURE OF THE CITY TOURISM AND CULTURAL AFFAIRS OFFICE OF THE CITY OF KORONADAL**

Be it enacted by the Sangguniang Panlungsod of the City of Koronadal, Province of South Cotabato, in session assembled, that:


**Section 1.** Organizational Structure. The City Tourism and Cultural Affairs Office shall have the following Organizational Structure:

**ENACTED** this 26th day of January 2021, in the City of Koronadal, Province of South Cotabato.


