EXPLANATORY NOTE

In adherence to the mandates of the Department of the Interior and Local Government (DILG) and the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID), the City Government of Koronadal, through this August Body has made mandatory the wearing of face masks in the City of Koronadal and strict compliance with the social distancing policy, by virtue of Ordinance No.8, Series of 2020 otherwise known as "An Ordinance on the Mandatory Wearing of Face Mask and the Reiteration on the Strict Observance and Compliance with the Social Distancing Policy to Stem the Spread of Covid-19 in the City of Koronadal", setting forth the corresponding penalties for the violation thereof.

Given the present increase in the number of violators of the aforementioned ordinance, and as stricter preventive measure to contain the widespread of Covid-19 in the entire City of Koronadal, it is prudent to amend its Penal provision, and to impose a stiffer penalty. Hence, this Ordinance:

**AN ORDINANCE AMENDING SECTION 5 OF ORDINANCE NUMBER 8, SERIES OF 2020
OF THE CITY OF KORONADAL**

 Be it enacted by the Sangguniang Panlungsod of the City of Koronadal in session assembled, that:



Section 1. Section 5 of Ordinance No. 8, Series of 2020 is hereby amended to effect the following:

Section 5. PENAL PROVISION

The offender shall pay or settle the corresponding penalty in violation of this Ordinance, to wit:

| • First Offense | - Fine of Three Hundred Pesos (PhP 300.00) |
| • Second Offense | - Fine of Five Hundred Pesos (Php 500.00) |
| • Third and Succeeding Offenses | - Fine of One Thousand Pesos (Php 1,000.00) or imprisonment upon the discretion of the court. |


Section 2. EFFECTIVITY. This Ordinance shall take effect upon its approval.
