AN ORDINANCE CREATING THE POSITION OF POPULATION PROGRAM OFFICER III WITH SALARY GRADE (SG) 18 UNDER THE CITY POPULATION OFFICE IN THE CITY OF KORONADAL

WHEREAS, Section 458 of the Local Government Code of 1991 provides that the Sangguniang Panlungsod has the power to approve ordinances and pass resolutions necessary for an efficient and effective city government and in this connection shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds;

WHEREAS, the City Population Office, takes charge in the implementation of programs on population development or responsible parenthood as stipulated in the Local Government Code of 1991;

WHEREAS, the said Office has three existing plantilla positions and it is a necessity and relevant to create additional position of Population Program Officer III with Salaray Grade (SG) 18 to fulfil its mandate subject to Civil Service law, rules and regulations, and directives of other concerned national government agencies;

NOW THEREFORE, be it enacted by the Sangguniang Panlungsod of the City of Koronadal, Province of South Cotabato, in session duly assembled, that:

Section 1. CREATION. The Population Program Officer III with Salary Grade (SG) 18 under the City Population Office is hereby created subject to the standards and guidelines prescribed by the Civil Service Commission and other concerned national government agencies.

Section 2. QUALIFICATIONS, DUTIES AND FUNCTIONS.

Qualifications:

Education : Bachelor's Degree
Experience : Two (2) years relevant experience
Training : Eight (8) hours of relevant training
Eligibility : Career Service (Professional) Second Level Eligibility

Generic Functions:

1. Supervise the implementation of programs and activities on responsible parenthood & family planning.
2. Develop project proposals, training designs and syllabi and recommend mechanisms & strategies to strengthen program implementation.
3. Develop presentations materials for RPPF.
4. Spearheaded the conduct of lectures and trainings.
5. Spearheaded the conduct of advocacy activities (Search for Model Families, KATROPA Congress).
6. Act as resource speaker/facilitator to trainings and seminars.
7. Establish strong linkages with partner agencies.
8. Review and consolidate reports on AHYD program implementation.
9. Perform other functions that may be assigned by the head of the division/office.


Section 3. FUNDING. The fund required for the position of Population Program Office III shall be taken from the appropriated budget duly enacted for the purpose and/or succeeding Annual Budget, subject to the limitations prescribed by the Republic Act No. 7160.

Section 4. REPEALING CLAUSE. All ordinances, executive orders, issuances, rules and regulations inconsistent with the provisions of the ordinance are hereby repealed or amended accordingly.


Section 5. SEPARABILITY CLAUSE. If, for any reason, any part or provision of this ordinance is declared invalid or unconstitutional, any part or provision not affected thereby shall remain in full force and effect.
