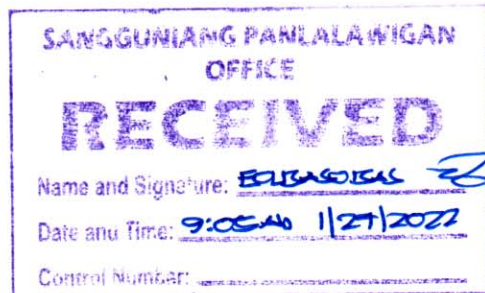

**AN ORDINANCE AMENDING SECTION 5 OF ORDINANCE NO. 28, SERIES OF 2021, OTHERWISE KNOWN AS THE "BULIG SA KUBOS" PROGRAM OF THE CITY OF KORONADAL**

**WHEREAS**, Ordinance No. 28, Series of 2021, was enacted by the Sangguniang Panlungsod in order to provide a well-defined policies/guidelines and a standard system of availment of assistance and benefits to make the program of the city more efficient, responsive, accessible and fair to all;

**WHEREAS**, last December 27, 2021, the City Mayor has affixed his signature on the said enactment, thereby, approving the said ordinance;

**WHEREAS**, however, on January 17, 2022, the City Mayor sent a letter to the Sangguniang Panlungsod requesting for some amendment on the said ordinance;

**WHEREAS**, while the Sangguniang Panlungsod firmly believed that the enacted ordinance will cater to a more diverse assistance which will benefit more individuals, especially the poor, but more importantly it will be fair and just to all, nevertheless, amendments in the ordinance may provide more clarity and substantial benefits to the beneficiaries of the program;

**NOW, THEREFORE**, be it ordained by the Sangguniang Panlungsod in session assembled, that;

**Section 1.** Section 5 of Ordinance No. 28, Series of 2021, is hereby amended and it shall be replaced and shall be read as follows:

**“Section 5. General Guidelines.**

a. In the availment of any of the benefits under the “Bulig sa Kubos” Program, the following original documents shall be presented and a certified true copy, which shall be authenticated by the personnel of the program, shall be submitted to “Bulig sa Kubos” Program Section/Desk for processing:

1. Proof of Residency (Either Voters Certification or Barangay Certification), and;
2. Such other documents necessary to support any request for assistance under the “Bulig sa Kubos” Program, such as the following:

**2.a Hospital and Billing Assistance (In-patient or discharged patient)** – Final Billing Statement or Statement of Account or promissory note to the hospital or clinics for the discharged patient.

**2.b Medical Procedure/Treatment and Laboratory Assistance** – Medical Abstract or Request Slip signed by the physicians

**2.c Maintenance Medication Assistance** – Latest prescription (within 6-months) together with Doctor’s diagnosis

**2.d Dialysis Treatment Assistance** – Statement of Account or Request Slip signed by the physician

**2.e Funeral and Burial Assistance** –Certified True Copy of Death Certificate

**2.f Assistance Requesting for Apparatus** (prosthesis, hearing-aid, glasses) – Medical Abstract or Clinical Summary or Request Slip signed by a physician

b. Assistance can be availed of by the beneficiary/grantee not more than once in every quarter, if necessary, except for dialysis treatment.

c. The assistance to be provided through this program maybe in a form of cash, check, guaranty letter, promissory note, coupon or stub, which shall be determined by the “Bulig sa Kubos” Program Section/Desk.

d. The assistance to be provided will be based on the following schedule of benefits:

**1. Hospital and Billing Assistance:**

- e. However, the City Mayor or the Officer In-Charge (OIC) City Mayor may, if necessary and reasonable considering the gravity and severity of the circumstance/situation/medical condition, on a case-to-case basis, decide to increase the assistance provided in this Ordinance and expand the services and assistance not covered herein.”

**Section 2. REPEALING CLAUSE.**


All laws, Ordinances, rules, regulations and other issuances or parts thereof, which are inconsistent with this ordinance are hereby repealed or modified accordingly.

This Ordinance shall take effect immediately upon approval.
