**EXPLANATORY NOTE**

Section 13(c) (5) of RA No. 7160 provides that the Sanggunian in consultation with the Philippine Historical Commission may change the name of a public place or building owned by a Local Government Unit;

Due to the conflagration that transpired last October 2017 which eventually destroyed almost half of the structures of the City Public Market, the City Government immediately responded for its rehabilitation and find sources of funds for its major renovations and even construction of new buildings and facilities included therein;

With the completion of some of its structural developments, the City Government deemed it necessary and proposes to rename the "City of Koronadal Public Market" to **City of Koronadal Central Supermarket Complex** and naming its Central Building as such with the intention of establishing the same as the center of local trade and commerce in the City as well as in the Province of South Cotabato, hence this Ordinance:

**ORDINANCE NO. 4**  
**Series of 2022**

**AN ORDINANCE RENAMING THE "CITY OF KORONADAL PUBLIC MARKET" TO "CITY OF KORONADAL CENTRAL SUPERMARKET COMPLEX" AND NAMING ITS CENTRAL BUILDING AS SUCH**

**Be it enacted** by the Sangguniang Panlungsod of the City of Koronadal, Province of South Cotabato, in session assembled, that:


**Section 1.** The City of Koronadal Public Market is hereby renamed as "City of Koronadal Central Supermarket Complex" and accordingly naming its Central Building as such.

**Section 2. REPEALING CLAUSE.** All laws, ordinances, rules, regulations and other issuances or parts thereof, which are inconsistent with this Ordinance are hereby repealed or modified accordingly.


**Section 3. EFFECTIVITY.** This Ordinance shall take effect immediately upon approval.

**ENACTED** this 14<sup>th</sup> day of February 2022, in the City of Koronadal, Province of South Cotabato.
