



CONTRACT AGREEMENT

THIS AGREEMENT, made this FEB 15 2024 between the **City Government of Koronadal** (herein called "the Entity") of the one part and **MARBEL DYNAMIC BUILDERS of A. Morrow St., Brgy. Zone II, City of Koronadal, Philippines** (herein called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **PROCUREMENT FOR THE SUPPLY & DELIVERY OF MATERIALS FOR THE COMPLETION OF MINI DAM AT PRK. MAUNLAD, BRGY. SARAVIA, CITY OF KORONADAL** has accepted a Bid by the supplier for the Supply of those goods and services in the sum of **ONE MILLION THREE HUNDRED SEVENTY EIGHT THOUSAND FIFTEEN PESOS (Php 1,378,015.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this agreement, words and expressions shall have the same meaning as are respectively assigned to them in the condition referred to;
2. The following documents shall be deemed to form and be read and constructed as part of this Agreement, viz:
 - a. the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted, including corrections to the bid resulting from the Procuring Entity's bid Evaluation;
 - b. the schedule of requirements;
 - c. the Technical Specifications;
 - d. the General Conditions of the Contract;
 - e. the Special Conditions of the Contract;
 - f. the Performance Security; and
 - g. the Entity's Notice of Award.
3. In consideration of the payment to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respect with the provisions of the contract;
4. The Entity hereby covenants to pay the Supplier in consideration of the provisions of the goods and services and the remedying defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.



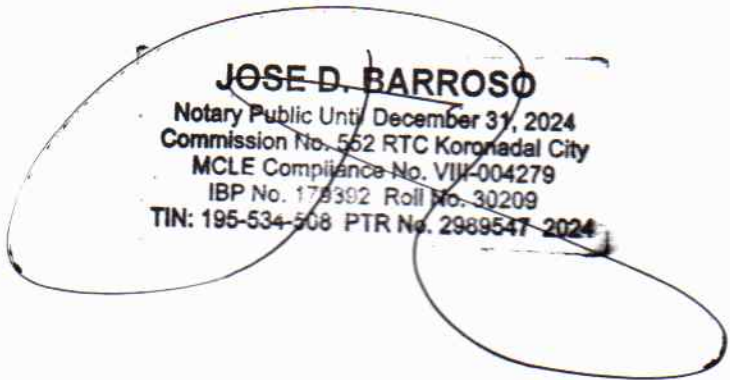
