## Description

INVITATION TO BID FOR THE CONSTRUCTION OF COVERED LINED CANAL ALONG AURORA STREET, BRGY. ZONE IV, CITY OF KORONADAL

1. The CITY GOVERNMENT OF KORONADAL, through the ANNUAL BUDGET 2024, intends to apply the sum of FIVE MILLION, SEVEN HUNDRED NINETY THOUSAND PESOS (PHP 5,790,000.00), being the Approved Budget for the Contract (ABC) to payments under the contract for CONSTRUCTION OF COVERED LINED CANAL ALONG AURORA STREET, BRGY. ZONE IV, CITY OF KORONADAL with Project Identification Number: ITB-KOR: 24-03-0026 CEO. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The CITY GOVERNMENT OF KORONADAL now invites bids for the above Procurement Project. Completion of the Works is required within a maximum of NINETY-EIGHT (98) CALENDAR DAYS. Bidders should have completed, within TEN (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
