## Description

INVITATION TO BID FOR THE REHABILITATION OF RIZAL PARK (PHASE 3), CITY OF KORONADAL - REBID

1. The CITY GOVERNMENT OF KORONADAL, through the LOCAL DEVELOPMENT FUND 2024, intends to apply the sum of FOUR MILLION, EIGHT HUNDRED TWENTY-SEVEN THOUSAND, THREE HUNDRED THIRTY-SIX PESOS & 89/100 (PHP 4,827,336.89), being the Approved Budget for the Contract (ABC) to payments under the contract for REHABILITATION OF RIZAL PARK (PHASE 3), CITY OF KORONADAL - REBID with Project Identification Number: ITB-KOR: 24-06-0079 CArchO. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The CITY GOVERNMENT OF KORONADAL now invites bids for the above Procurement Project. Completion of the Works is required within a maximum of ONE HUNDRED THIRTY-FIVE (135) CALENDAR DAYS. Bidders should have completed, within TEN (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

3. The City Government of Koronadal will hold a Pre-Bid Conference on 21 MAY 2024, 2:00 PM at the Bids and Award Committee (BAC) Office, 3F, Room 301, New City Hall, Purok Villegas, Brgy. Zone III, City of Koronadal, which shall be open to all prospective bidders.

Philippine Standard Time (PST) observed at the BAC Office shall be followed as the official time. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
