The CITY GOVERNMENT OF KORONADAL, through the ANNUAL BUDGET 2024, intends to apply the sum of SIX MILLION, TWO HUNDRED SEVENTY-FIVE THOUSAND PESOS (PHP 6,275,000.00), being the Approved Budget for the Contract (ABC) to payments under the contract for CONCRETING OF JUNCTION JUDGE ALBA STREET & PRK. MABINULIGON ROAD (PRK. ARTIEDA) BLOCK 2 WITH LINED CANAL, BRGY. ZONE III, CITY OF KORONADAL with Project Identification Number: ITB-KOR: 24-08-0111 CEO. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The CITY GOVERNMENT OF KORONADAL now invites bids for the above Procurement Project. Completion of the Works is required within a maximum of ONE HUNDRED THIRTY-EIGHT (138) CALENDAR DAYS. Bidders should have completed, within TEN (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion

as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
