INVITATION TO BID FOR THE PROCUREMENT FOR THE SUPPLY & DELIVERY OF DRUGS & MEDICINES FOR THE CITY HEALTH OFFICE, CITY OF KORONADAL

The City Government of Koronadal, through the ANNUAL BUDGET 2024, intends to apply the sum of ONE MILLION, THREE HUNDRED NINETY-NINE THOUSAND, SIX HUNDRED THIRTY PESOS (PHP 1,399,630.00), being the Approved Budget for the Contract (ABC) to payments under the contract for PROCUREMENT FOR THE SUPPLY & DELIVERY OF DRUGS & MEDICINES FOR THE CITY HEALTH OFFICE, CITY OF KORONADAL with Project Identification Number: ITB-KOR: 24-09-0127 CHO. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The City Government of Koronadal, now invites bids for the above Procurement Project. Delivery of the Goods is required within the maximum of SEVEN (7) Calendar Days from the receipt of the Notice to Proceed (NTP). Bidders should have completed, within TEN (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

4. Interested Bidders may obtain further information from City Government of Koronadal and inspect the Bidding Documents at the address given below during office hours from 13 AUGUST 2024 to 12:00 NN, 03 SEPTEMBER 2024.
