The CITY GOVERNMENT OF KORONADAL, through the LOCAL DEVELOPMENT FUND 2025, intends to apply the sum of ONE MILLION, NINE HUNDRED THIRTY-TWO THOUSAND, FOUR HUNDRED-ONE PESOS & 03/100 (Php 1,932,401.03), being the Approved Budget for the Contract (ABC) to payments under the contract for the CONSTRUCTION OF LINED CANAL – COVERED LINED CANAL – 0.8M × 0.8M × 200.0 LN.M, NATIONAL HIGHWAY (TAMBILAWAN) TO BULOK CREEK, PRK. LA TRINIDAD, BRGY. ZONE I, CITY OF KORONADAL with Project Identification Number: ITB-KOR: 25-02-0023 CEO. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The CITY GOVERNMENT OF KORONADAL now invites bids for the above Procurement Project. Completion of the Works is required within a maximum of NINETY (90) CALENDAR DAYS. Bidders should have completed, within TEN (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion

as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

4. Interested bidders may obtain further information from CITY GOVERNMENT OF KORONADAL and inspect the Bidding Documents at the address given below during office hours from 28 JANUARY 2025 to 12:00 NN, 18 FEBRUARY 2025.
